NEWS FROM THE OP SHOP

The Op Shop plans to re-open on Wednesday November 3. All of the volunteers must be double-vaccinated. If there are any volunteers who do not feel comfortable working at the Op Shop during the pandemic, please let the Day Person know. If anyone in the Congregation would like to assist as a COVID Marshall for 2 to 3 weeks of opening the op Shop again, please contact Val. We will organise a roster. We would like to have two shifts each day: 10.30am - 1.00pm and 1.00pm - 4.00pm. *Val*

VACCINATION REQUIREMENTS FOR AUTHORISED WORKERS - paid or volunteer workers

As of Friday October 22, any authorised worker in Victoria must have received at least one dose of COVID vaccine, and must receive their second dose by November 26 - to be able to work from any workplace other than their own home. They must also have provided evidence of their vaccination status to their workplace. This applies to paid or voluntary work.

The list includes faith leaders, marriage celebrants and funerary services, including broadcasting or pre-recording. It also includes people providing the essential safety maintenance of properties, cleaning, gardening, op shop volunteers and even church organists,

Lorraine, as Church Council Secretary, is collecting this information which will remain confidential. Please contact Lorraine with date of second vaccination, 12-digit vaccination certificate number, type of vaccination (AZ, Pfizer) OR date of first vaccination, appointment date for second vaccination, type of vaccine OR date and number of Certificate of Exemption for those who are medically exempt.

RE-OPENING FOR FACE-TO-FACE WORSHIP

At its meeting on Wednesday 20th of October, the Church Council made the following decisions regarding our return to face-to-face worship, acknowledging that as a community of faith, we want to make our decisions with love for the whole of community.

- Face-to-face worship services will resume for members of the public who have received both doses of the vaccination, one dose and proof of a booking for a second, or a certified medical exemption, from the Sunday two weeks following the state reaching 80% full vaccination. It is estimated that our first Sunday for face-to-face worship will be on the 14th of November.
- 2. Worship will continue to be streamed online and the printed service material will continue to be available to those who want it.
- 3. All information regarding the requirements of entry, density limits etc will be clearly displayed on all entry points to the building and published in the newsletter and on the website.

If you are having problems working with the QR Codes and Digital Certificate information on your phone, please let Lorraine Threlfall via our email address. The Church Council will schedule a time to open up the Narthex on a Sunday afternoon, with some technical gurus, to help get these things set up for you.

The latest information from the Synod Crisis Management Team (published 21/10/21) regarding numbers in the building is

Religious gatherings and ceremonies –As of October 22:

- If all attendees are fully vaccinated, up to 30 people can attend indoors, with a density quotient of one person per 4 sqm, or up to 100 people may attend outdoors with a density quotient of one person per 2 sqm.
- If the vaccination status of all attendees is not known, there is no change to the prior cap of up to 20 people with a density quotient of one person per 4sqm.
- **COVID check-in marshals** must ensure all attendees check-in and, if it is a service for the fully vaccinated, that all attendees over 12 have proof they are fully vaccinated or medically exempt.
